1 Introduction

This report provides an analysis of the diversity profile of the Board of Trustees at Elmore. The Board of Trustees are the volunteers who have overall responsibility for management of the charity.

It is supplemented by a Workforce Equality Report and a snapshot of the diversity profile of some of Elmore's clients.

The publication of this Trustee Equality Report is voluntary and done to improve the equality, diversity, and inclusion of our organisation, and become a more inclusive employer, service provider, and partner. The ambition to be an anti-discrimination employer and service provider was set by the team in our strategy 'Holding the Hope,' approved by the Board in February 2022.

2 Uses of this report

As Elmore's first annual Trustee Equality Report, the information will be used along with other workforce data to:

- work towards action plans in 2023 as we seek a Board that is representative of our wider community and clients
- establish a baseline for annual analysis of our data across the protected characteristics
- monitor and measure progress in achieving our action plans
- assess how all our policies and practices impact on equality and diversity
- begin to benchmark our diversity profile with the sector or relevant parts of the sector
- report annually to our Board of Trustees, service user forum, and team, and to external stakeholders including commissioners, partners, and the wider community

3 Trustee Equality Monitoring

3.1 Sources of data

- The data about the diversity profile of the Board is derived from a snapshot of all Trustees on 20th October 2022.
- The 2021 Census Data provides information about the demography of the population in Oxfordshire.

3.2 Data collection

- The survey was hosted online and emailed to potential respondents.
- Trustees were encouraged to respond; the survey was not mandatory.
- Assurances were provided in relation to confidentiality and use of the data.
- The survey was short. Eleven questions were put to potential respondents, all answerable by tickbox. Respondents took an average of 1.5 minutes to complete the survey.

3.3 Presentation of data

• The information in the report has been presented in percentage format to maintain confidentiality, due to the small numbers of respondents involved.



3.4 Non-disclosure

- The provision of data was voluntary, there is a 100% response rate.
- For two categories (ethnicity and religion/belief) 'undefined' was provided as one response.
- The tables below show the percentage of respondents who chose the 'Prefer not to say' or 'Undefined' options under these categories.

3.5 Headlines of this Workforce Equality Report

3.5.1 Gender

- Half of respondents are women (50%), which is slightly below that of the population of Oxfordshire at 51%. Half of respondents are men (50%), which is slightly above that of the population of Oxfordshire at 49%.
- The gender identity of all respondents matched their sex as registered at birth.

3.5.2 Age

• The largest age group is 55-59. The next largest age group for respondents is equally 25-29, 35-39, 45-49, and 60-64, showing a range of ages.

3.5.3 Ethnicity

• The majority respondents are 'White' (83%) and 17% undefined. 100% of trustees who responded regarding ethnicity are White.




3.5.4 Disability

- Two-thirds of respondents do not have a disability. Of the third, who do, the most common disability is physical impairment (progress or long-term illness) and learning difficulty (for example, dyslexia).
- 3.5.5 Sexual Orientation
 - All respondents identify as 'heterosexual' (100%).
- 3.5.6 Religion/Belief
 - Half of respondents are 'Atheist'. 16.66% of responses identified with 'Undefined', 'Christianity' and 'Spiritualism' equally.

The following chart shows the gender of respondents, compared to the 2021 Oxfordshire census data (1):

- The gender profile is balanced.
- All respondents disclosed that their gender identity matched their sex as registered at birth.



- The largest age group for Elmore Trustees is 55-59.
- The next largest age group for respondents is equally 25-29, 35-39, 45-49, and 60-64, showing a range of ages.
- The 2021 census data for Oxfordshire shows a much flatter distribution in age. However, the Trustee results have low statistics, hence a large statistical uncertainty.

The following chart shows the ethnicity of respondents, compared to the 2021 Oxfordshire census data (2):



- The majority (83%) of respondents are 'White' and 17% are undefined, compared with 87% from the Oxfordshire census.
- 100% of trustees who responded regarding ethnicity are White.

3.9 Disability

The following chart shows the disability/non-disability of respondents, compared to the 2021 Oxfordshire census (3):

The main observations are:

• Two-thirds of respondents do not have a disability. This is below the Oxfordshire census value of 85%. However, this includes 8% of people who have a long-term physical or mental health condition but day-to-day activities are not limited.

For respondents who considered themselves to have a disability, they considered themselves to have any of the following. Respondents were encouraged to tick all that applied, meaning one or more individual may have disclosed one or more disabilities.

¹ Other disabilities were provided as options for respondents to choose as applicable. They received 0% responses. These include sensory impairment: visual impairment, physical impairments including two options: mobility impairment and physical co-ordination difficulties, communications impairment including two options: speech impairment and BSL user.



• Of the third, who have a disability, the most common is physical impairment (progressive or long-term illness) and learning difficulty (for example, dyslexia).

3.10 Sexual Orientation

The following chart shows the sexual orientation of respondents, compared to the 2021 Oxfordshire census data (4):

The main observations are:

• 'Heterosexual' is the largest proportion of respondents at 100%. This is above the value for Oxfordshire which is 88 %. However, the statistics for the trustee data are low.

- Half of respondents are 'Atheist', higher than the Oxfordshire census value of 40%.
- 16.66% of responses identified with 'Undefined', 'Christianity' and 'Spiritualism' equally.
- The percentage of trustees who Identify as Christian is notably lower than the census value of 47%.
